4. Neighbourhood Plan Policies & Projects Group report

- **a.** The Hove Station Quarter Concept (Master) Plan Draft 3 update. There are 1.5 days worth of work available from AECOM. (see item d)
- **b.** Hove Gardens Matsim Development There have been numerous attempts to understand the priorities of the Local Planning Authority and Matsim. The Forum understands discussions with these two have taken applications forward potentially by addressing objections from the various council departments. The Forum understand there has been agreement for the provision of £1m investment in public real improvements and an increase of the proportion of affordable housing to15%. There are, however, still problems concluding these negotiations and the Forum is continuing their efforts to secure agreement between parties. There are two major conflicts with the City Plan the Waste Management site which should be resolved in August, and the Newtown Road Industrial site for which MG is to do more work, possibly with a graduate assistant planner from Brighton University.
