3.1 Neighbourhood Plan Examination

- The Independent Examiner requires that the Basic Condition Statement of Compliance be rewritten to detail in textual format the points of compliance with the National Policy Planning Framework and the Local Development Planning Framework. It will then be resubmitted for a supplementary Section 16 public consultation before submission to a Council Committee meeting probably in September. MG and HL will meet with the Independent Examiner and Robert Davidson on May 5th to clarify the procedure and timescale.
- The Independent Examiner recommends that ideally the Forum appoint an independent consultant. To avoid further delay and unnecessary cost the Forum's preference in agreement with Robert Davidson is for MG and HL to prepare the amended Basic Condition Statement and commission a peer review before submission.
